# **Health & Safety Requirements for 2022 National Service Training — West**

June 1-3, 2022 · Albuquerque, NM

We look forward to seeing you at the National Service Training — West event in Albuquerque in less than two weeks. Please carefully review this message for important information on event health and safety entry requirements.

This message is to provide you with information on how to use the CLEAR Health Pass to meet our health and safety requirements for entry. Please review this and make sure you meet these requirements prior to attendance. You can review ASC's Health and Safety code of conduct here.

All attendees for ASC 2022 National Service Trainings are required to meet our event safety requirements. This includes:

- Proof of COVID-19 Vaccination or Negative PCR COVID-19 Test submitted to our vendor. (If you are
  unable to use the CLEAR app please bring your vaccine card and ID or copy of your negative test
  results within 72 hours.)
- At this time, per CDC Guidance, masks will be optional, as community levels in Albuquerque are reported as low. This is subject to change. Masking requirements may be adjusted per CDC guidance, if community levels change.
- Respecting other people's distancing decisions, ASC will have stickers (red, yellow, and green) for name badges for attendees to self-identify their comfort level with personal distancing.

#### **COVID Vaccine/Testing Verification**

ASC is using a third-party vendor, EventFarm, to verify COVID-19 vaccination or negative test status of all attendees via an integration with the CLEAR Health Pass. This will require the use of the CLEAR app on your

mobile smart phone or tablet.\*

For the most efficient entry possible, every attendee should enroll with CLEAR before the event to complete their COVID-19 pre-screening at least 24 hours in advance of registration check-in on Wednesday, June 1. Once your vaccination record has been uploaded to the platform, it can typically take up to 30 minutes for your status to be verified. We encourage all attendees to complete this process at least 24 hours before the event.

The following are step by step instructions, which can be downloaded here.

#### Step 1: Download and enroll in CLEAR.

- Download the CLEAR app in the <u>Apple App Store</u> or the <u>Android App Store</u>.
  - Tap on the white Health Pass tile.
  - Select "Have a Code?" and enter the Code: EFATTENDEE206
- Tap "Enroll or verify your identity in CLEAR" to create your CLEAR member account.
  - **New to CLEAR?** When prompted, enter your email address and phone number, and have your government issued photo ID ready to complete enrollment.
  - **Already a CLEAR member?** Use the email address associated with your membership, and snap a quick selfie to verify your identity.
- Continue to follow prompts on the Entry Requirements page to securely confirm your proof of vaccination or negative test results.

If you will be entering a PCR test within 72 hours of attendance in lieu of vaccination, please <u>review</u> the list of PCR providers that partner with CLEAR. PCR tests from other providers will not be accepted. This list of providers is also available in the CLEAR app. We recommend booking an appointment to ensure availability within the 72 hour window.

#### Step 2: Before arriving to the event, complete your Health Pass for faster entry at check-in.

- Open the CLEAR app, and tap on the white Your Pass tile.
- Confirm your identity with a guick selfie.
- Tap "Open Health Pass" to get your result. Green means you're good to go!

Disclaimer: CLEAR will not share your specific data about your vaccination or test results with ASC.

\*If you do not have a smartphone or tablet, you may bring a photo ID and vaccination card for review by ASC staff on-site.
